Charitable Gifts Advance the Mission of the MHC

Supporting the scholarship, preservation, and collections mission of the Medical Heritage Center is an investment in honoring and disseminating the unique medical history of the central Ohio region.

Private contributions are a critical resource in sustaining and expanding the educational programs, historical scholarship, collections, exhibits, and preservation projects of the MHC. There are many ways to help, and a variety of giving options can be matched to individual philanthropic, financial, and tax needs.

GIFTS OF CASH – Often the most convenient form of giving and can be put to immediate use in a variety of areas at the MHC, including annual support and endowments. Cash gifts are fully deductible for federal income tax purposes, provided deductions are itemized.

PLEDGES – Enables a donor to plan a personal giving program that is both convenient and tax-wise. A multi-year pledge to the MHC allows a donor to consider a more significant gift than would otherwise be possible. Terms for payment on pledges are flexible and determined by the donor.

SECURITIES – Securities may be made as outright gifts or as a payment on a pledge. Stock certificates may be reassigned directly to The Ohio State University Foundation or may be transferred through the donor's broker. The mean market value on the date of the transfer will determine the value of the gift for tax purposes.

PLANNED GIFTS – In some circumstances, it is preferable to consider a long-term planned gift to support the Medical Heritage Center. This can be accomplished through various gift plans, such as annuities, charitable remainder trusts, and simple bequests. Planned giving experts who are members of Ohio State's Planned Giving Office are available to discuss individual questions and tailor a plan specific to each donor's goals.
